If the animal(s) covered by this contract becomes ill or is injured, Hollywood Dog Training School shall attempt to notify the owner, or owners specified agent to discuss an advisable course of action. If the owner or owners agent cannot be contacted in a reasonable time frame or if the animals state of health requires immediate attention, Hollywood Dog Training School is authorized to obtain the services of a licensed veterinarian. Hollywood Dog Training School shall follow treating veterinarian direction if pet is in life threatening situation. If pet is not in life threatening situation Hollywood Dog Training School shall have said pet stabilized while owner or agent is contacted for consultation. The owner of the treated pet shall agree to promptly pay all charges for veterinarian services. If the owner of the pet has requested that the pet be treated by his own specified veterinarian, Hollywood Dog Training School will assume no responsibility for time lost due to distance or unavailability of said veterinarian, there will also be a transportation and time charge for kennel personnel tending treated pet.

SERVICES TO BE RENDERED

- (1) Hollywood Dog Training School agrees to board the above described animal hereinafter referred to as the "animal", and to provide the other services specified above at the time that the animal is picked up by or delivered to the owner, at the completion of the services.

CHARGES

- (2) The Owner agrees to pay for the above specified services at the rates stated in advance or at the time that the animal is picked up by or delivered to the Owner after completion of services. In the event the dog is not picked up by Owner after completion of services, Owner agrees to pay reasonable daily boarding charges as set forth herein above or as may be deemed reasonable.

STATUS OF ANIMAL

- (3) The person signing this contract is assumed to be the legal owner of said animal or directed agent of legal owner. No animal will be allowed to be taken off the premises except by the person entering into this contract or by his expressed agent. The owner specifically represents that he is the sole owner of the animal and that there is no lien or mortgage against the animal. The owner guarantees that the animal is in good health and has not been exposed to any contagious disease including but not limited to rabies, distemper, or parvo virus within the past thirty days.

LIMITATION OF LIABILITY

- (4) Kennel shall exercise reasonable care for pet delivered by the Owner to kennel for boarding. It is expressly agreed by Owner and Kennel that Kennel's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200 per animal boarder. It is also agreed that owner hereby indemnifies, defends and holds harmless Hollywood Dog Training School from any and all damages or injuries caused to individuals or property which are caused by owners animals.

LIEN

- (5) The owner hereby grants a lien on the animal to Hollywood Dog Training School for all charges resulting from boarding and rendering any other services to the animal. If any such charges shall be unpaid for a period of (15) days after they become due in accordance with the terms of this contract, Hollywood Dog Training School may, upon (10) days notice in writing to the owner, specifying the amount due and informing him that the payment of the amount due within (10) days will entitle him to redeem the animal, sell the animal at public or private sale to satisfy the account. Notice may be served by registered or certified mail with return receipt requested, addressed to the address of the Owner as stated above. The proceeds of the sale, after paying the expenses thereof, shall be applied to liquidate the indebtedness secured by the lien, including all charges accrued in caring for animal up to the date of sale, and the balance if any, shall be paid over to the Owner. If the proceeds of the sale are insufficient to pay the expenses of the sale and the aforesaid indebtedness and accrued charges, the Owner shall pay the difference to Hollywood Dog Training School. In addition, if any animal has not been picked up within (10) days of the stated pickup date the animal will be assumed abandoned and Hollywood Dog Training School may upon (5) days notice in writing to the owner, redeem the animal sell the animal at public or private sale to satisfy the account. If pet is not able to be sold he will humanely be put to sleep.

BREACH

- (6) If action at law or inequity is necessary to enforce the terms of this agreement, Hollywood Dog Training School shall be entitled to reasonable attorney's fees, cost, and necessary disbursements in addition to any fees to which said parties may be entitled.
